This is the way in which you prove to Local 211 you would be a responsible member and good employee. You may not quit while on probation. If you have a problem on the job, call the Business Agent who dispatched you. If you are terminated for cause or quit a job during your probationary period, you may NOT re-apply for the Out of Work List or for membership with Local 211. You did not take advantage of your opportunity to prove yourself.

I understand that if I am dispatched on a 30 day or 60 day probation and I fail to finish that probation because I quit or am terminated for cause, I am NOT eligible to register for the Out of Work List and I am NOT eligible for membership in Pipe Fitters Local Union 211.
