2016 COMMUNITY IMPROVEMENT FUND SCHOLARSHIP APPLICATIONS NOW AVAILABLE

This year Local 211 will be awarding 10 scholarships in the amount of \$1,500.00 each.

WHO MAY APPLY: Applicant must be a high school senior or returning college student planning to attend a university, college or technical institute in the Fall term. Priority will be given as follows:

- 1. DEPENDENT children (as defined by Health & Welfare rules) of members of Local Union 211 graduating from High School who are beginning college in the Fall of 2016 will be given first priority.
- 2. Second priority will be given to DEPENDENT children (as defined by Heath & Welfare rules) returning to college in the Fall of 2016.
- 3. Members of Local 211 and their spouses will be given third priority.
- 4. Any other applications for scholarships to be addressed on a case-by-case basis.

TIMELINE:

Monday, May 2, 2016 Applications and study materials made available to the membership. Packets must

be picked up at the Union Hall.

Friday, July 1, 2016 Deadline for turning in applications for processing.

Friay, July 15, 2016 Deadline for interviews.

Tuesday, July 26, 2016 Final selection of scholarship recipients will be made.

Wednesday, Aug. 10, 2016 Deadline for award letters to be mailed.

Wednesday, Aug. 24, 2016 Deadline for money to be deposited with the educational facilities of the winners.

OUT OF WORK LIST

REMINDER...You are required to re-sign to stay on the list at least every 30 days. This requires filling out another registration form, or calling someone at the hall and having one filled out. Talking to an agent does not qualify as a re-sign. The list is cleaned off periodically, and those who have not resigned are automatically dropped off the list. Once you have been dropped, you may not be backdated regardless of claims that you have talked to an agent. You will need to re-register in order to get a new sign up date and go to the bottom of the list.

DID YOU KNOW...? Working Women and Unions

- Women make up about 45 percent of all union members and are projected to be the majority by 2025.¹
- Women represented by labor unions working full time, ages 16 and older — earn an average of 30.9 percent more per week than do nonunion women.²
- Approximately 74 percent of female union members have a pension plan, compared with only 42 percent of their nonunion counterparts.³
- · Women in unions are 21 percent more likely to have paid sick leave.4
- Raising the federal minimum wage to \$12 by 2020 would boost wages for more than 19 million working women.⁵
